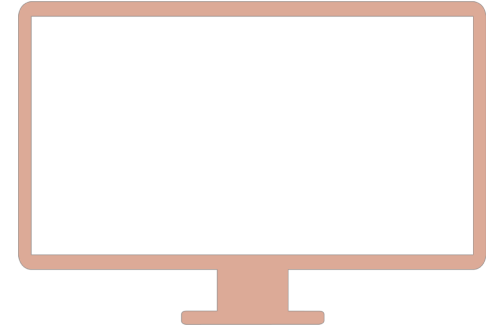

Gather Data Publication Request

- ⦿ Demand Driven
- ⦿ Request based on ICANN Data Asset Inventory
- ⦿ Submit the request via an ICANN system

Assessment for Publication

- ⦿ Consider privacy rights and recognizes ICANN's legal obligation
 - ⦿ Does ICANN have the right to publish the data?
 - ⦿ Would publication violate any law, any contract, and or any person's privacy?
 - ⦿ Was the data provided to ICANN with the expectation that it would be kept confidential?
 - ⦿ Would publication be inappropriate pursuant to the Defined Conditions for Nondisclosure in the ICANN Documentary Information Disclosure Policy?
- ⦿ Assess technical feasibility of publication
 - ⦿ Assess data source readiness

Proposed Draft Data Publication Process Approach

Conclude Assessment & Communicate

- ⦿ Communicate the assessment of the requested data for publication
- ⦿ Anticipate timeline for publication

Develop Data Pipeline

- ⦿ Extract the data/ Cleanse as needed
- ⦿ Transform data if warranted by Privacy and other concerns
- ⦿ Exercise the ICANN data pipeline to port data to the ODP “test area”

Proposed Draft Data Publication Process Approach

QA and Publish Data

- ⦿ Test data to ensure Privacy (GDPR etc) rules have been respected
- ⦿ Validate data for consistency with other data in the ODP Portal
- ⦿ Push data to the ODP (PROD) Portal

Communicate New Data Publication

- ⦿ Communicate New Data Publication
- ⦿ Engage with community
